EXECUTIVE SUMMARY

The 1990 Indiana State Legislature enacted House Bill 1240 requiring counties to form solid waste management districts. The core responsibilities of the districts are to implement a 20-year solid waste management plan to reduce the reliance on Indiana landfills and to ensure final disposal capacity for the community.

The Allen County Solid Waste Management District (ACSWMD) was established on April 2, 1991. The District developed a comprehensive solid waste management plan designed to protect the environment and fulfill the statewide reduction goals. The plan was approved by the Indiana Department of Environmental Management (IDEM) in December 1992. The plan outlined the cooperative measures of private and public sector delivery of services. This private/public partnership has enabled the District to provide cost effective programs.

The District's role is to strengthen the existing infrastructure and provide the education and knowledge necessary to achieve reduction goals. This annual report documents our progress toward achieving these goals in 2009.

ORGANIZATIONAL STRUCTURE

The Allen County Solid Waste Management District is a single-county District governed by a seven board of elected officials. The Board consists of three Allen County Commissioners, a representative of the Allen County Council, the Mayor of the City of Fort Wayne, a representative of the Fort Wayne City Council and a representative of the Monroeville Town Board. The Board conducts monthly meetings, usually held on the last Tuesday of the month, with additional meetings held as needed. The Board is responsible for approving all financial matters, the hiring of staff, creating policies and adopting ordinances in an effort to fulfill the District's mission.

The Board is supported with its tasks by a Citizen's Advisory Committee (CAC). The mission of the CAC is to assist and advise the Board in the development and implementation of the district's solid waste plan.

The ACSWMD by statute is a taxing unit; the District currently receives 95% of its revenues from landfill tipping fees, not property taxes. Waste received within the District is assessed at \$1.35 per ton. Waste received outside the District is assessed at \$2.50 per ton.

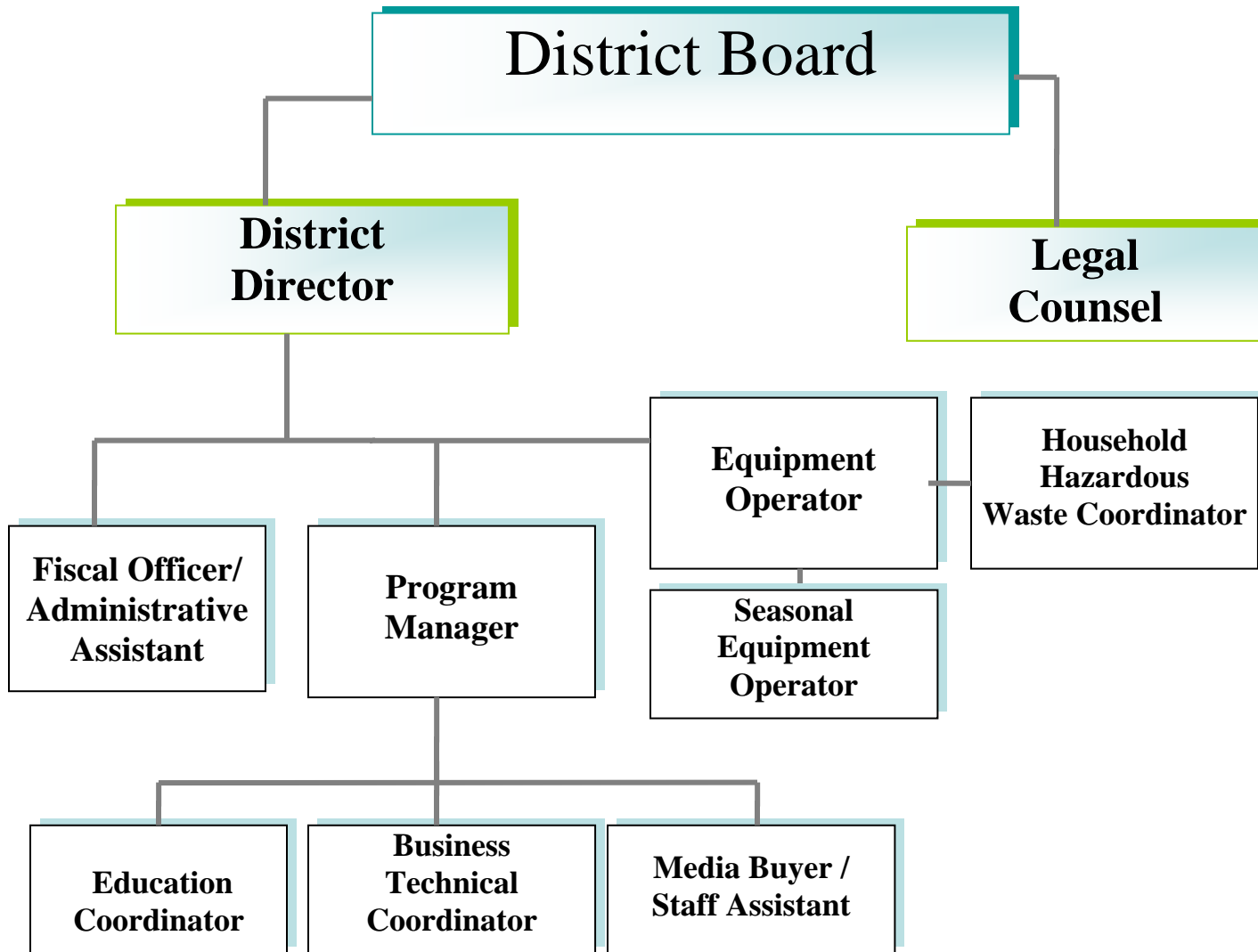

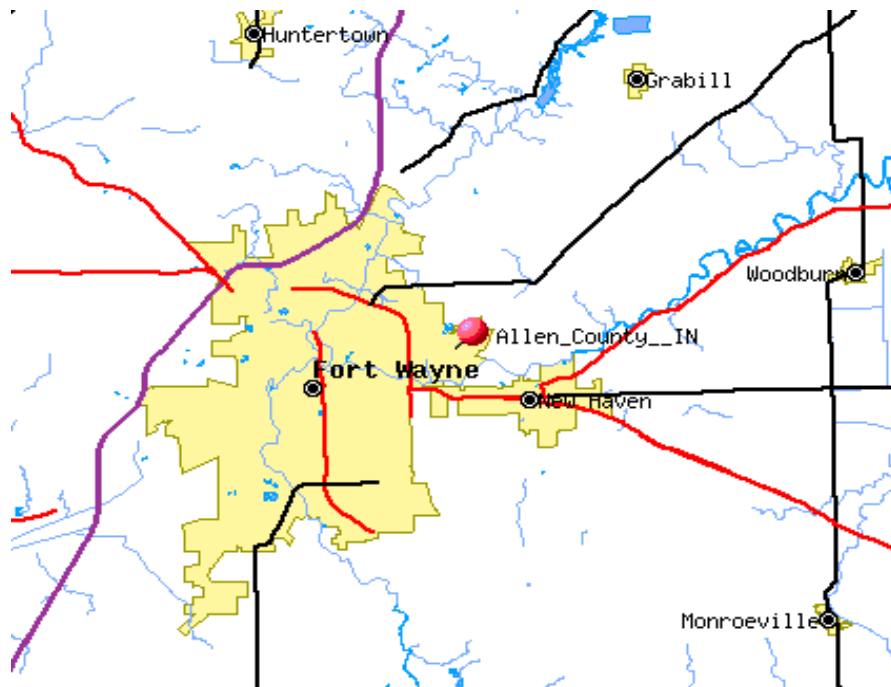

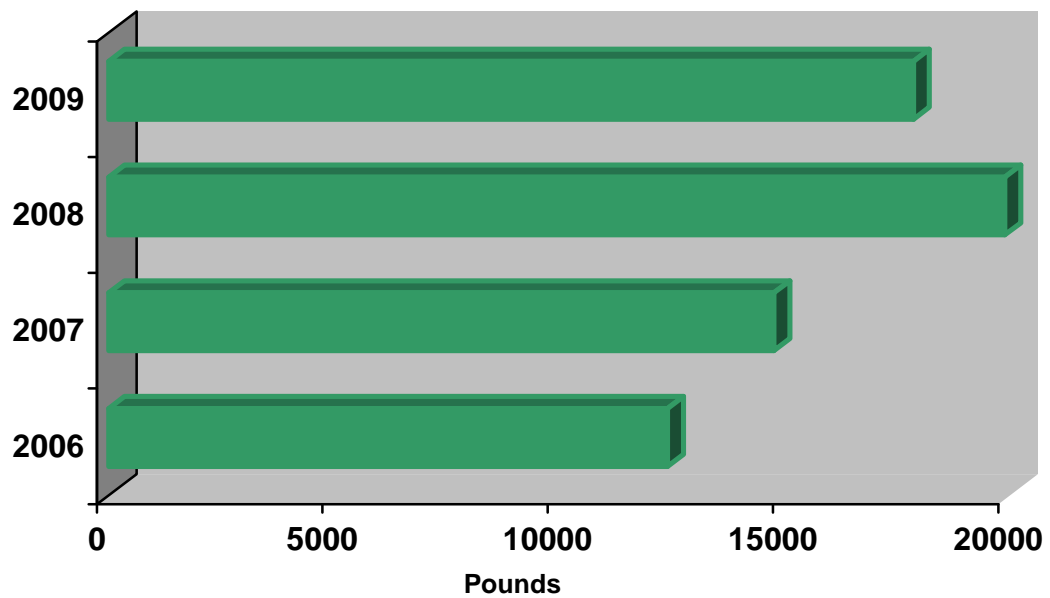
Residential Battery Recycling Program

Since May 1999, the Allen County Solid Waste Management District and Batteries Plus have been working together to collect old and used batteries that contain chemicals harmful to our environment. Over 17,850 pounds of batteries were collected from Allen County residents in 2009.

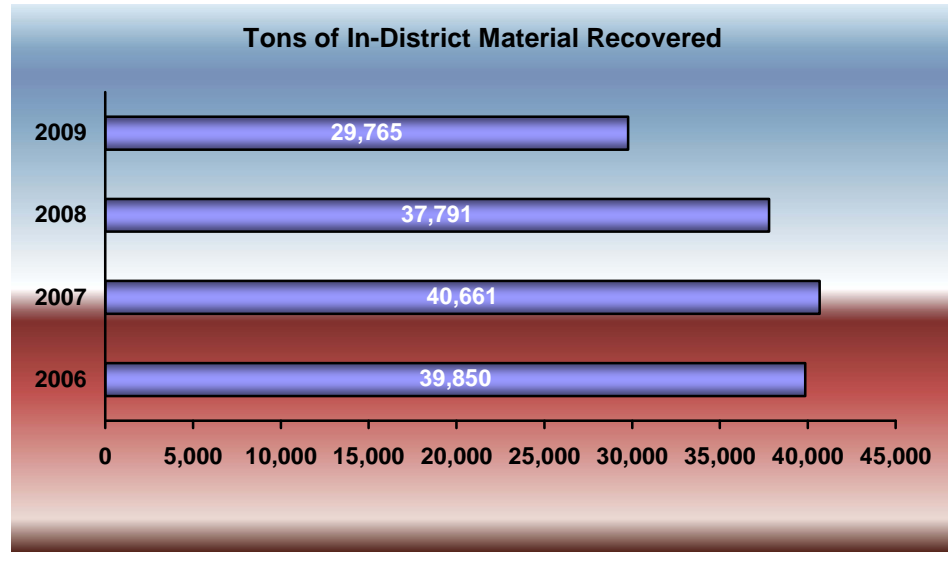

Diversion Credit Program

The District provides financial backing to eligible recycling processors for recycling specific materials from the residential and commercial waste stream. Materials currently receiving support include: glass, plastics, steel cans, newspaper, magazines, phone books and mixed paper.



Subsidy credits are established by the ACSWMD Board Members with rates being separate for commingled residential recyclables, source-separated residential recyclables and commercially generated recyclables. Approved processors file monthly reports with the District outlining all incoming material and sales.

Financial support of this program has expanded existing processing capacity in the District and has kept the cost of recycling services economical.

The source-separated and commercial rates remained at \$5.00 per ton respectively in 2009. A rate change with commingled material was approved by the Board in January due to decreases in the commodity market prices. The commingled rate increased from \$10.00 to \$19.29 per ton. A total of 29,765 tons of in-district material was reported by the business in 2009.

Trash-To-Treasure Art Contest

Local residents had a chance to express their creativity while reusing unwanted items from their homes and turning them into works of art. The 11th annual “Trash-To-Treasure” Art Contest took place at Science Central on Saturday, April 18th.

Contestants from six different age categories made their art out of 100% recycled material. All 72 artists and eight group projects that participated received a Certificate of Recognition.

The District along with WANE TV, Science Central, OmniSource Corp., National Serv-All, SES Environmental, Pizza Hut and Fort Wayne Children’s Zoo sponsored the 2009 event.

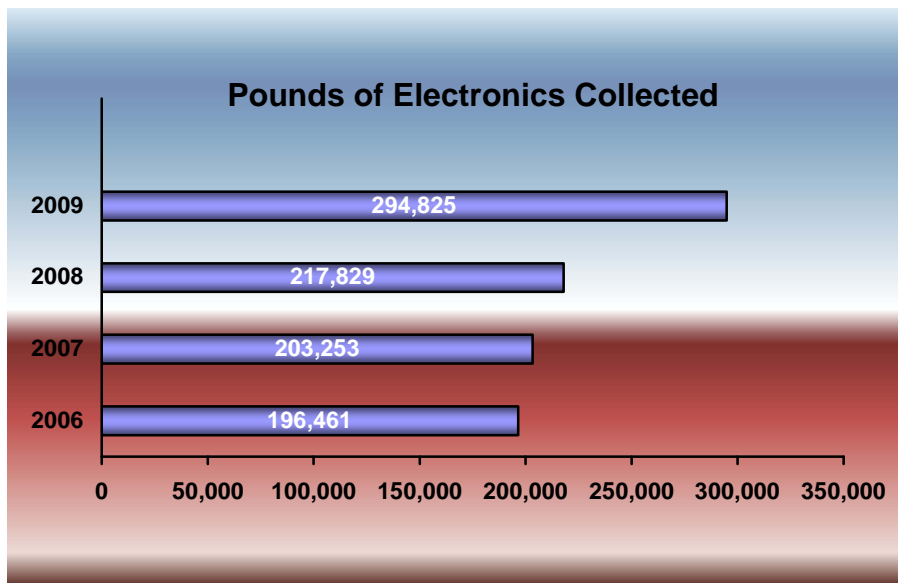
Electronics Recycling Program 2009

Electronic products are a growing waste stream in today's society. In Allen County, the District's Electronic Recycling Partnership Program with OmniSource Corp. has recovered and/or recycled 147 tons or 294,825 pounds of electronics in 2009.

Mercury Reduction Initiative

The District expanded its mercury reduction efforts in 2009, adding three additional fluorescent bulb recycling locations for residents.



Since February 1999, the Allen County Solid Waste Management District has worked with Sears at Glenbrook Mall to collect spent four-foot fluorescent bulbs from residents. In November 2006, the District partnered with Connolly's Do-It-Best Hardware Stores to collect bulbs up to eight-foot in length and compact fluorescent lamps (CFL's). In January 2009, Grabill Hardware and two Umber's Do-It-Best hardware stores joined the community program.

This statewide program entered its tenth year in 2009. Under this grant project, the Indiana Department of Environmental Management covers 50% of costs associated with collecting, recycling and transporting mercury. Each district who participates in the program is responsible for the remaining 50% costs.

In 2009, over 161,900 ft. of fluorescent bulbs were recycled through the partnership programs. Over 5,100 other lamps were collected in the program which included; CFL's, HID and U-Tube lamps. An additional 281 pounds of mercury debris and 734 pounds of mercury devices were retrieved and processed in our collection efforts.

Household Hazardous Waste Collection Program

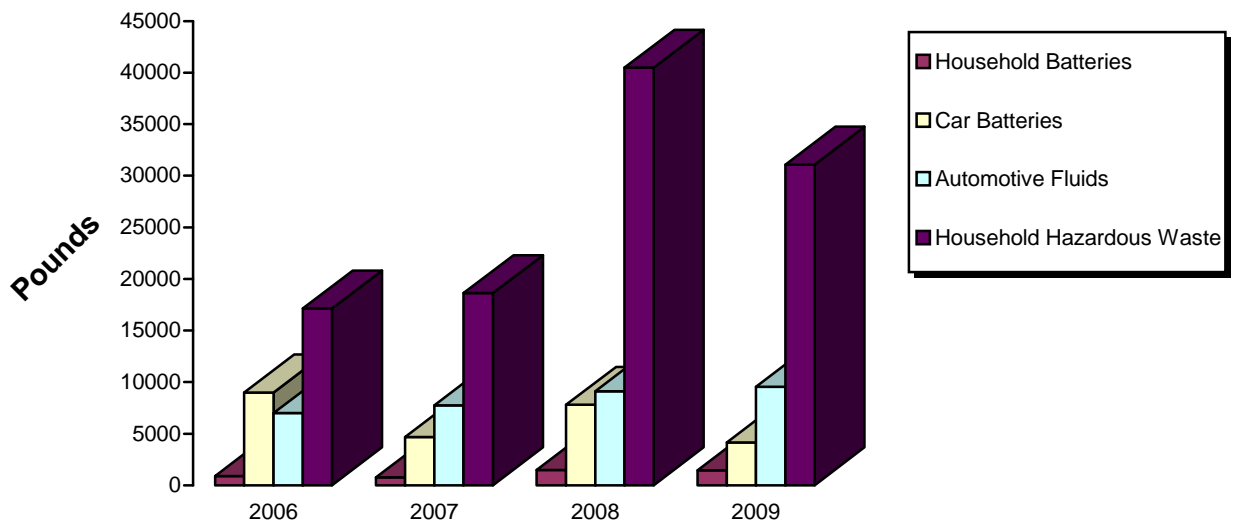
This year's Household Hazardous Waste (HHW) collection program brought in over 46,200 pounds of material from residents. Nearly half of all residents surveyed stated they were first time participants in this year's collection event.

The program takes place in the fall and allows residents to properly and safely dispose of their household hazardous waste.

Residents were charged \$5.00 for up to 10 gallons of liquid or 50 pounds of dry waste. \$1.00 was charged for each additional gallon of liquid waste or 5 pounds of dry waste. Residents were charged \$.25 per fluorescent light bulb.

Tire Management Program

Overall, the District was responsible for collecting and processing 8,246 tires in 2009.

An annual event, Tire Amnesty Day, allows residents and neighborhood associations the opportunity to rid themselves of used tires in a responsible manner. The October 4th tire event took place at Citilink on Leesburg Road. Liberty Tire Recycling of South Bend, Indiana, was the contractor for the event.



Waste Oil Program

The District encourages residents to dispose of their used motor oil, oil filters, anti-freeze and other auto fluids in an environmentally friendly manner. Items can be taken to any Allen County Hires Auto Parts locations or at Doehrman Repair Service in Woodburn. There is no charge to residents for dropping off their items.

Yard Waste Management Program

The District offers financial assistance to two large scale composting facilities. The facility at 6231 MacBeth Road is located in southwest Allen County. The northeast compost site is located at the City of Fort Wayne's Bio-Solids, Lime and Yard Waste Recycling facility at 5510 Lake Avenue. The District provides both sites with grinding services with the tub grinder rotated on a schedule. Over 8,500 tons of material was brought into the compost sites in 2009.



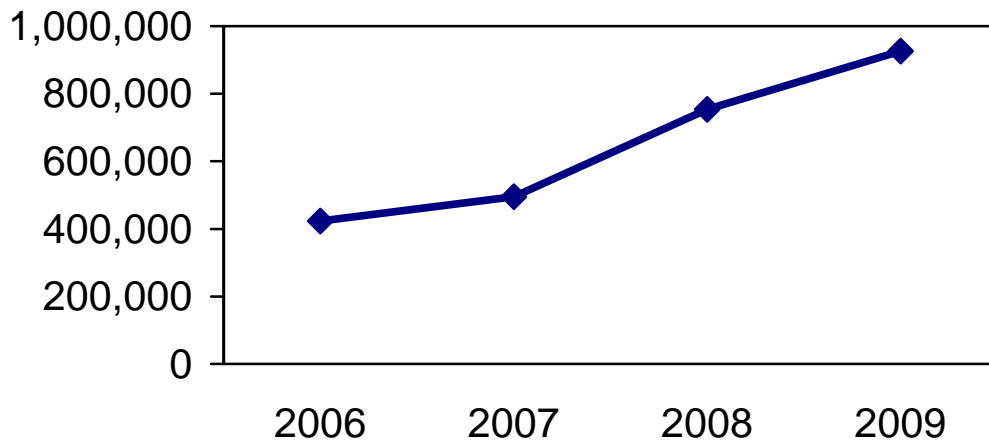
Christmas Tree Recycling

Beginning the day after Christmas, Allen County residents may bring their live Christmas trees to be chipped into mulch at one of several drop-off sites throughout the community.

The District utilized its tub grinder to mulch Christmas trees at Foster Park West, Franke and Shoaff Parks. Trees were chipped at McMillen Park and in Leo/Cedarville.

The Districts web site, www.acwastewatcher.org, continues to break records year after year with 926,334 hits in 2009.

Annual Web Site Hits



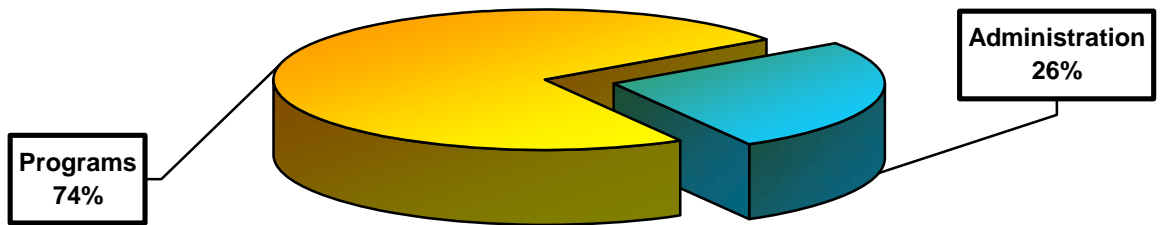
